MINUTES OF EPF OFFICERS' ASSOCIATION MEETING CONDUCTED ON
9TH SEPTEMBER, 2018

The EPF Officers' Association (EPFOA) conducted its General Council meeting on 9th of September 2018 at 11 AM at the PDNASS, New Delhi. As the previous Central Executive had completed its tenure on 15.08.2018, therefore, the meeting was presided by three of the senior-most officers present, Shri Jag Mohan, Addl. Central PF Commissioner (HQ), Shri K.L. Goyal, Addl. Central PF Commissioner (HQ) & Shri R.K. Singh. Addl. Central PF Commissioner / Outgoing President of EPFOA.

The officer-members present at the meeting passed following resolutions through show of hands:

1. The elections to constitute a new Central Executive of the EPFOA must be held immediately in the said meeting.
2. The composition of the Central Executive must be reformed to better reflect the varied interests of various batches & groups of member-officers. Therefore, the central Executive of the EPFOA would comprise of one representative from each batch/group. If so required, representatives to the Central Executive shall be added after due consideration and due process. The Constitution of the EPFOA to be amended to reflect above amendments.
3. It was also decided that the new Central Executive shall formulate further amendments to the Constitution after due discussions with stakeholders.

Thereafter, as per above resolutions, elections were held at the meeting for constituting fresh Central Executive for a two-year term. The following officers were elected unopposed :
