facing stagnation in the cadre of APFC and RPFC-II  
which has led to a demoralizing effect on the officers.  
Further, it is also seen that as and when a post has fallen  
vacant, the same is not being filled up in time which has  
further aggravated the situation.

In the meeting held with your goodself on  
24.9.2014, it was decided that relaxation in the  
qualifying service for promotion from APFC to RPFC-II  
and for RPFC-II to RPFC-I will be given so that the  
officers who are on the verge of promotion could get  
promotion.

It is, therefore, requested that your goodself may kindly accord relaxation in qualifying service for promotion from RPFC-II to RPFC-I and APFC to RPFC-II so that the officers who are due for promotion may get promotion in time.
