The EPF Officers Association would like to
express our sincere gratitude for the steps taken by your
goodself towards relaxation in qualifying service for
regular promotion from APFC to RPFC-II and RPFC-II to
RPFC-I which otherwise would not have been possible..

As you are aware, the relaxation in qualifying
service was required for promotion from APFC to RPFC-
II and RPFC-II to RPFC-I and the same has been
approved by the competent authority. As regards to
consultation with UPSC, the Ministry has conveyed to
UPSC as well as EPFO that the existent Recruitment
Rules will continue till Amendment to the Act is made.

Sir, for the last one year there are no promotions
in the Group 'A' Officer cadre even though the officers
who are on the verge of promotion, having completed
the required qualifying service, are available. This has
led to unrest among the officers fraternity.

Since the required relaxation for promotion from APFC to RPF-C-II and RPF-C-II to RPF-C-I has already been approved by the competent authority, it is requested that your goodself may kindly look into the matter and convene DPC for promotion in the Group 'A' Officer cadre
