Sir,

Please refer to above cited subject and reference.

In this regard it is submitted that the Central Executive of the EPF Officers' Association has discussed the issue of attending the meeting called for by the CPFC, vide above cited HO letter, and decided to request you to kindly defer the said meeting to another date convenient to you.

The reason for requesting for deferment has been discussed below, but firstly, I would like to submit that, it has never been the intention of EPF Officers' Association to write so-called "*derogatory correspondences*" to the management or anyone else, but rather only to put forward facts and to stand for truth. Nowhere have we used foul or abusive language or stated anything that

can be proved to be a lie or falsehood. It is indeed unfortunate that our correspondences have been misunderstood as “*derogatory*” to the authorities in any way.

Now, coming to the primary reason for our request for deferment, it is submitted that your aforesaid letter does not provide for any agenda for the said meeting but just states “*One of the main issues is series of derogatory communications being received from Secretary General, EPF Officers’ Association*”. It is humbly submitted that the EPF Officers’ Association has, vide earlier communications, raised a multifarious range of pending HR-related issues including cadre restructuring, grant of STS to APFC, pending promotions, service confirmation of new recruits, regularisation of promoted APFC, grant of NFSG, grant of NFU (despite the R.K. Kukreja Committee constituted for said purpose having submitted its report), etc., which we would like to discuss at the earliest for their amicable resolution, but it seems they have not been made a part of the meeting agenda. Hence, it would be beneficial if a detailed agenda incorporating above pending issues is prepared for the proposed meeting.

Furthermore, it is requested that the agenda for any proposed meeting may kindly be forwarded to the EPF Officers’ Association considerably in advance so as to allow the Central Executive to prepare & discuss the issues amongst itself as well as to obtain the views of the General Body of EPF officers before presenting our consolidated stand before the management. This is so because, as earlier intimated to you, the views presented by EPF Officers’ Association, including our correspondences, are based upon the responses received from the General Body of EPF Officers, since in the interest of democracy & transparency, all interactions & correspondences with management are made only after putting the management’s letters in public domain and calling for comments / suggestions from the General Body.

The proposed meeting on 19.01.2016 has been called at a very short notice, particularly when considering that 15.01.2106 was a gazetted holiday for many parts of the country. This did not allow us any meaningful time to prepare our issues in a cogent manner and may not result in a fruitful meeting.

Therefore, in view of above, we once again request you to kindly defer the said meeting to a more convenient date; and we also request you to kindly provide the agenda for any proposed meeting considerably in advance so as to ensure a result-oriented & successful meeting.
