**Subject: Declaration of time table for conduct of
election to the Central Executive of the
EPF Officers' Association – Reg.**

Madam/Sir,

As you are aware, in accordance with Article No. 3 of the Constitution of EPF Officers' Association, the official year of the Association shall commence on 1st day of January of each year and end on the 31st December of the same calendar year. The usual procedure for holding biennial elections to the Central Executive of the Association involved a General Council Meeting (GCM) at the then-NATRSS, New Delhi, sometime during the month of December, and thereafter election were held for the new Central Executive by the members & delegates present at the GCM. However, during December 2013, due to then prevailing circumstances in our Organisation, elections could not be held.

Subsequently, GCM was held on 01.02.2014. In the said GCM, as the sufficient numbers of participants were not available, it was decided that the existing Central Executive shall continue in office till next elections are held through electronic means. Subsequently, elections could finally be held only by August 2014, and the present Central Executive took office on 15.08.2014.

Therefore, even though as per article no. 3 of the constitution of EPFOA the prescribed two-calendar-year term is not yet over, the current Central Executive shall be completing two years in office on 15.08.2016. Accordingly, it is felt that in wider democratic interest and on moral grounds it would be appropriate to hold election for Central Executive, so as to ensure that it is in place by 15.08.2016.

In this regard, it is intimated that the EPFOA has bought a software package for holding electronic elections from a software vendor located at Tirunelveli. As the software vendor is located at Tirunelveli it would be technically desirable that the monitoring of the running of the software is done by an officer located at that station so as to allow immediate technical assistance in event of any glitch. Accordingly, Shri Aakash Sonker, APFC, SRO Tirunelveli is hereby appointed as Election Officer for this election. He shall be co-chair with Shri Ramesh Kumar, APFC, RO Madurai, who shall also be an Election Officer. They shall, jointly, be responsible for smooth conduct of elections as per the prescribed schedule and declaration of results thereafter.


The time-table for the elections is attached with this letter as *Annexure-A*. As the election software requires registration of all members of the EPFOA, a link for the same has been provided on our website. It is requested that all members of the EPFOA should register themselves on the EPFOA website, as per schedule, and thereafter, follow the prescribed time line scrupulously.

It is hoped that all our members shall participate in this process whole-heartedly thus raising the democratic structure of our Association even higher.
