Subject: Request for urgent intervention to prevent undue victimisation of Sh. Shyam Veer Tonk, Regional Provident Fund Commissioner-II – regarding.

Respected Sir,

It is to solicit your kind attention on news item appeared on 17.08.2016 in national media about sacking of Sh. Shyam Veer Tonk, OSD to Minister for Labour & Employment and Regional Provident Fund Commissioner-II in EPFO and derogatory remarks against the Hon'ble CBT members and ministry officials regarding allegation of any foul play in approving Cadre-Restructuring. However, a clarification has been issued on above news item by the concerned media agency on 18.08.2016 which clearly reflects haste and lack of due diligence by the concerned media agency in publishing above news item on 17.08.2016.

It appears from the news reports that above action has been initiated in consequence

to written complaint by representative of Section Officers Association of EPFO. Sir, it is a

common understanding that any Cadre-Restructuring proposal may bring some benefits to

some section and even some loss to another section that may cause discontent among

another section. However, solution lies in reconciling all aspirations in accordance with

democratic principles and not in allegations and undue victimisation. Such incidents coupled

with unparallel stagnation have potential to frustrate entire officers' community thereby

negatively affecting attainment of organisational goals. Deeply frustrated and demoralised

officers' community can't be expected to focus on attainment of organisational goals single

mindedly.

Therefore, EPFOA convened emergency meeting this afternoon in

PDDUNASS, New Delhi where unanimous resolution was passed condemning such conduct

of office bearer of EPF Section Officers Association and hastened step taken by media in

publishing news without verifying the facts. Any action to malign image of organization and

its stake holders including Hon'ble CBT members and officer fraternity is completely

unwarranted and seeks your kind urgent intervention to prevent victimisation of Sh. Shyam

Veer Tonk, RPFC-II and harm to the reputation of EPFO & CBT.

The officers' community would look for your confidence and expect an urgent

intervention in this regard so as to dispel notions of any frustration and discontentment in the

cadre.
