promotion to the post of RPFC- I and expediting finalization of Recruitment

Rules for Commissioners' Cadre (EPF),

Group A - reg.

Respected Sir,

Please refer to the subject cited above. The undersigned would like to bring to kind notice of your good self

that recently the regular promotion date to the post of RPFC-II has been preponed to 01.04.2012 in case of some officers

vide Head Office Order No. HRM-II/A-9(1)2011/93 dated

05.04.2017. Consequent to issuance of above said order, it

has become necessary to conduct fresh / review DPC for

promotion to the post of RPFC-I since officers whose date of

regular promotion to the post of RPFC-II has been preponed

have attained eligibility for promotion to the post of RPFC-I. Further, many ACC and RPFC-I posts are lying vacant as on date and requisite officers in the feeder cadre of RPFC-I and RPFC-II respectively are available for consideration for promotion but the DPC process could not be initiated due to non-finalization of new Recruitment Rules for Commissioners' Cadre (EPF), Group A. This is leading to delay in granting promotional benefits to eligible officers in the grade of RPFC-II and RPFC-I to RPFC-I and ACC respectively.

Sir, in view of aforementioned position, it is earnestly requested to kindly fast-track the finalization of new Recruitment Rules for Commissioners' Cadre (EPF), Group A and also issue suitable directions for conducting fresh / review DPC for promotion to the post of RPFC-I so that eligible officers in the grade of RPFC-II and RPFC-I can be considered for promotion to the post of RPFC-I and ACC without further delay.
