Please refer to above cited letter & subject matter. In this regard the EPF Officers' Association (EPFOA) requests to include following items in the agenda of the proposed meeting of EPF CSWC & EPF CSPB:-

1. Comprehensive cashless medical insurance policy from reputed insurance provider for employee and family.
2. Term life cover for employees (with insurance benefits equal to 7 times of gross annual income).
3. Reimbursement of COVID-19 pandemic related expenses which could not be covered under extant rules may be allowed as a special measure.
4. For funds allocation to Regional Offices under Welfare Head, the ROs are at present categorised by employee strength in multiples of 100, this may be reduced and categories expanded with employee strength in multiples of 25 employees.
