benefit. The NFU benefit has been approved for EPFO Commissioner-Cadre

officers by the CBT, and is in keeping with the statutory mandate of Section 5D

(7) of the EPF & MP Act, 1952, however, due to continuous denial of the same,

the EPF officers have been forced to approach CAT for their legitimate rights.

The EPF Officers' Association (EPFOA) has represented the issue before your

goodself vide earlier letters dated 17/10/2024 & 03/03/2025. Furthermore,

during the meeting held by you on 04.03.2025 with EPFOA, you had graciously

consented to reconsider the issue.

3. In fact, this issue was then raised before EPFO management by the EPFOA

vide letter dated 28/01/2025, and it was also intimated to EPFO management

that we had raised this issue before your goodself during the meeting held by

you on 04.03.3025, and you had assured to reconsider the issue. Despite this,

EPFO management has refused to reconsider the issue.

4. It is requested that the matter may kindly be re-examined at earliest and

necessary directions may be issued to the Ministry for immediate action of

constitution of screening committee for grant of NFU.

5. It is also requested that the EPF Officers' Association (EPFOA) may kindly

be granted an appointment at the earliest to explain the issue in detail before

your goodself.
