3. Election of office bearers — consensus. 4. Eligibility. The consensus should have regard to the minimum length of service prescribed for each post by Article 8 of the Constitution. Length of service will be verified from official records before any declaration is made.

5. Where no consensus is reached. In respect of any post on which a consensus is not communicated by 02.09.2026, an election by the General Body will be held from **0001 hours on 04.09.2026 to 2359 hours on 07.09.2026**. The manner in which any such election will be conducted will be notified separately on or before 03.09.2026.

6. Announcement and constitution. The office bearers will be announced as soon as the position is settled, and not later than **08.09.2026**. The Central Executive for the term 2026-28 will be constituted on **09.09.2026**.
